The Organization is considered a national thought leader in animal welfare, in recognition of the uniquely successful lifesaving model it has pioneered in Austin, Texas. This model provides a comprehensive safety net for all shelter pets facing needless euthanasia. The Organization transfers in cats and dogs from other shelters that have no other option for leaving the shelter alive, treats them, and adopts them out. The Organization's practical, data-driven and sustainable model provides specialized programs and resources for saving the classes of at-risk, homeless cats and dogs that are typically killed in more traditional shelters, including neonates, elderly pets, those with critical illnesses and injuries, puppies with parvo, cats with ringworm and feline leukemia, unsocialized cats, and dogs with behavioral issues. Since 2016, the Organization has worked to broaden the reach of its model through education. It brings over 500 professionals a year from other shelters to learn how to replicate its lifesaving successes in their own communities, and sends its expert managers to other communities to help hands-on with implementing lifesaving changes.
